THE PROTECTION OF THOSE 690,000 ACRES ENSURES THAT VALUABLE WILDLIFE HABITAT, PRODUCTIVE FARMS AND RANCHES, IRREPLACEABLE SCENIC VIEWS, AND VITAL WETLANDS AND RIVER CORRIDORS WILL BE THERE FOR FUTURE GENERATIONS.
